

# Limited Warranty

**Duke Manufacturing Co.** warrants to the original buyer that its Equipment shall be free from defects in material and workmanship for the period specified in this warranty.



## **INTERNATIONAL LIMITED PRODUCT WARRANTY**

3 Year Limited Parts and 2 Year Labor  
(Exclude's Model TSC-6/18 Proofer/Oven)

The warranty period commences with the date of installation of the Equipment. All labor and parts expenses after expiration of the warranty shall be the responsibility of the end user. Duke Manufacturing Co. will bear the labor and parts expense during the warranty period.

Refrigeration compressors carry an additional two (2) years parts replacement warranty, (total of 5 years), not to include labor and freight.

The warranty includes travel time portal to portal, not to exceed 100 miles (160 km) round trip, or two hours total travel time. Repairs due to abuse, misuse, handling or harsh chemical action are not covered. Removal of the identification rating plate voids the warranty, as does operation at the incorrect voltage. Improper installation or unauthorized modifications made to the equipment by any party also voids the warranty. Damage due to floods, fire or other acts of God also are not covered. This warranty does not cover glass, routine maintenance activities, any failure that results from lack of, or improper equipment maintenance activities. Adjustments, such as leveling, calibration or tightening of fasteners normally associated with the installation related to plumbing, electrical or gas connections are the responsibility of the installer.

Duke Manufacturing Co. does not recommend or authorize the use of any product(s) in a non-commercial application, including but not limited to residential use. The use or installation of product(s) in non-commercial applications renders all warranties, express or implied, including the warranties of MERCHANTABILITY and FITNESS FOR A PARTICULAR PURPOSE, null and void, including any responsibility for damage, costs and legal actions resulting from the use or installation of product(s) in any non-commercial setting.

To the extent allowed by law, any express warranties or any implied warranties of merchantability or fitness are limited to the replacement guarantees above and any other warranty is disclaimed.
